The National E- Scholarship Schemes has been implemented by the Department of Empowerment of Persons with Disabilities( Divyangjan) and Developed by the National Informatics Center.

1. Pre-Matric Scholarship for Students with Disabilities.

The Students Should be a regular, full time Student Studying in a Govt. School or in a recognized by Govt. or by a central /State Board of Secondary Education.

1. Post-Matric Scholarship for Student with Disabilities.

The Students have passed the Matriculation or Higher Secondary Examination of a recognized University or Board of Secondary Education will be eligible.

2. Top- Class Education for students with Disabilities.

The Scheme will cover students with Disabilities (SWDS) for pursuing studies at the level of Post Graduate Degree or Diploma in any Discipline.

The Scheme will operate in all institution notified by the Department of Empowerment of Persons with Disabilities, Ministry of Social Justice and Empowerment as Institution of Excellence.

iv) Scholarship schemes are applicable to students with disability and having disability certificate issued by competent Medical Authority.


v) The institution has to approve the student.


